

Goodyear Blimp Competition – Terms and Conditions

1. The Promoter The promoter of this competition is TOCA ("Promoter"), of Thruxton Motor Racing Circuit, Thruxton, Andover, SP11 8PN, in association with Goodyear.

2. Eligibility 2.1 The Competition is open to UK residents aged 18 or over, excluding employees (and their immediate families) of the Promoter, Goodyear, and any agencies or third parties directly associated with the running of the Competition. 2.2 By entering, entrants confirm they meet the eligibility criteria above. 2.3 Only one entry is permitted per person. Multiple entries from the same individual will be void.

3. How to Enter 3.1 The Competition opens at 15:00 (BST) on Friday 3 July 2026 and closes at 15:00 (BST) on Saturday 4 July 2026 ("Competition Period"). Entries received outside the Competition Period will not be counted. 3.2 To enter, entrants must complete the entry form at <https://btcc.net/btcc-offer-fans-the-chance-to-fly-high-with-goodyear-blimp-competition/> with their full name, contact details and confirmation of availability, in accordance with the instructions on the BTCC website and associated social media channels. 3.3 The Promoter accepts no responsibility for entries that are lost, delayed, or not successfully submitted due to technical failure or otherwise.

4. Selection of Winners 4.1 Three (3) winners will be selected at random from all valid entries received during the Competition Period, using a random selection process. 4.2 Winners will be notified by email, as provided at entry, no later than 17:00 (BST) Saturday 5 July, following the close of the Competition. 4.3 If a winner does not respond by 12:00 (BST) Monday 7 July, or is unable to confirm their availability for the date specified in Clause 5.2, the Promoter reserves the right to select an alternative winner at random from the remaining valid entries.

5. The Prize 5.1 Each of the three winners will receive two (2) seats aboard the Goodyear Blimp for a single flight experience (the "Prize"). 5.2 The flight is scheduled to depart from Essex at 15:30 on Thursday 9 July 2026. The experience will last approximately 1 hour 30 minutes, and passengers must arrive on site at least 30 minutes prior to departure. 5.3 Winners and their chosen guest must be available on the date and at the time specified above. No alternative dates, times, or locations will be offered, and the Prize cannot be redeemed at a later date if a winner is unavailable. 5.4 There is no cash alternative to the Prize, and the Prize is non-transferable and cannot be exchanged, refunded, or resold. 5.5 Guests joining a winner must also meet the eligibility criteria in Clause 2 and may be required to sign a separate waiver or disclaimer prior to boarding. 5.6 Travel to and from the departure location in Upminster, Essex, is not included and is the sole responsibility of the winner and their guest.

6. Flight Cancellation and Weather 6.1 The Goodyear Blimp flight schedule is subject to change and may be delayed, rescheduled, or cancelled at any time, including at short notice or on the day of the flight, due to weather conditions, operational, or safety reasons beyond the control of the Promoter or Goodyear. 6.2 In the event of cancellation, the Promoter and Goodyear will make reasonable efforts to notify affected winners as soon as possible, but accept no liability for any costs, losses, or inconvenience arising from such cancellation, including but not limited to travel or accommodation costs

incurred by the winner or their guest. 6.3 The Promoter is not obliged to offer a rescheduled flight or any alternative prize in the event of cancellation.

7. Use of Image and Content 7.1 By entering the Competition and, if selected, participating in the Prize experience, winners and their guests consent to the Promoter and Goodyear capturing and using their name, image, and likeness in photography, video, and related content, for use across BTCC and Goodyear's marketing, social media, and promotional channels, without further compensation.

8. Data Protection 8.1 Personal data collected as part of this Competition will be used solely for the purposes of administering the Competition and fulfilling the Prize. 8.2 Winners' names may be published on BTCC's website and social media channels following the Competition, unless the winner notifies the Promoter otherwise at the point of entry.

General 9.1 The Promoter reserves the right to amend, cancel, or withdraw the Competition at any stage if deemed necessary in its opinion, or if circumstances arise outside of its control. 9.2 The Promoter's decision in all matters relating to the Competition is final, and no correspondence will be entered into. 9.3 This Competition is in no way sponsored, endorsed, administered by, or associated with any social media platform on which it may be promoted. 9.4 These terms and conditions are governed by the laws of England and Wales.
